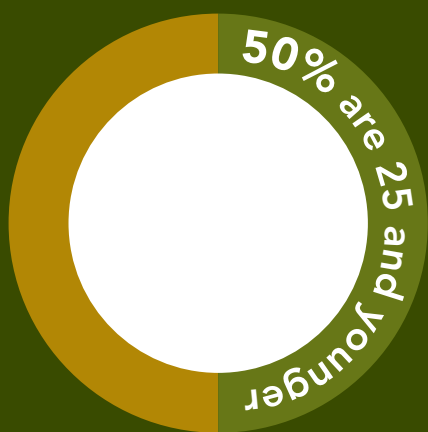

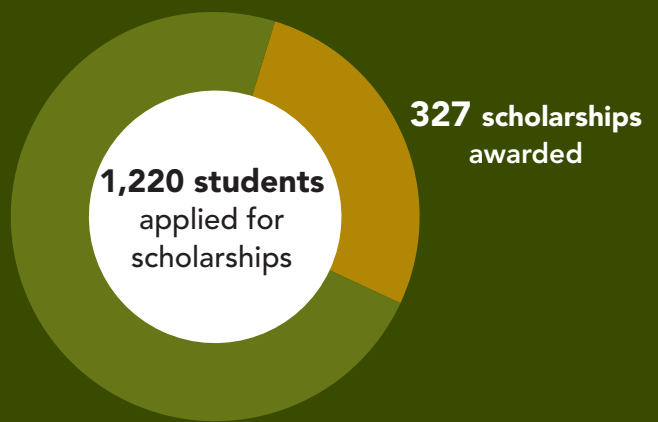

“Our goal is to support vineyards and wineries in their investment of educational opportunities for their employees,” says Dick Erath. “By training the next generation of vineyard managers and winemakers, we’re ensuring the success of this booming Oregon industry for years to come.”

Dick Erath and the Erath Family Foundation board care deeply about education and training the next generation of vineyard managers and winemakers.
